The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Terroristic Threats-Reckless Disregard Risk

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Charge Description: That on or about 3/27/2016, in Hennepin County, Minnesota, ABDUL RAHEEM HABIL ALI-SKELTON did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, Victim #1.

Charge Description: That on or about 3/27/2016, in Hennepin County, Minnesota, ABDUL RAHEEM HABIL ALI-SKELTON did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, Victim #3.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

That on March 27, 2016, at approximately 2:53 a.m., officers were dispatched to a Walgreens store, located at 7700 Brooklyn Boulevard in Brooklyn Park, Hennepin County, Minnesota, to investigate a disturbance. In route, officers were advised a male was threatening customers and employees of the store. Upon arrival, officers located and detained the suspect, identified as ABDUL RAHEEM HABIL ALI-SKELTON, hereafter defendant.

Officers spoke with a customer, an identified adult male, hereafter Victim #1. Victim #1 reported he arrived at the store and was confronted by defendant. Defendant accused Victim #1 of having relations with his (defendant's) girlfriend. Defendant threatened to hit Victim #1 with a bottle and advanced on Victim #1 multiple times.

Officers then spoke with the store manager, an identified adult male, hereafter Victim #2. Victim #2 reported he observed defendant following Victim #1 in the store and threatening to hit Victim #1 with a bottle. Victim #2 reported defendant advanced on Victim #1 multiple times. Victim #2 intervened and advised defendant and Victim #1 to leave the store. Defendant then stated he "had a gun" and would "shoot up the place." Defendant also made reference that he was part of a terrorist organization and would "blow up" the store. Victim #2 reported defendant's statements caused him to feel terrorized.

Officers then spoke with a store cashier, an identified adult female, hereafter Victim #3. Victim #3 reported she observed defendant enter the store, approach Victim #1 while holding a bottle, and use the bottle to threaten Victim #1. Victim #3 reported she called for managerial assistance and that her manager arrived and attempted to escort defendant from the store. Victim #3 reported defendant then threatened to "blow up" the store.

Defendant was detained in a squad car. During this detention, defendant admitted he said he would "shoot up" the store and admitted he stated he possessed a gun. Defendant was transported to the police department. During a post-Miranda interview, defendant admitted: going into the store and arguing with Victim #1, that he had a bottle and used it to scare Victim #1, that he now did not remember threatening to "shoot up" the store, but that he did remember referencing a terrorist organization and saying he would "blow up" the store.

At present, defendant is in custody.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
